COMMODITY DEFINITIONS

Commodity Exports	Definition
Concentrates	Copper ore concentrates, zinc ore concentrates and lead ore concentrates.
Machinery, Project Cargo & Vehicles	Mining machinery, agricultural machinery, power generation machinery, construction machinery, rail wagons, passenger vehicles and commercial vehicles.
Meals & Grains	Barley, sorghum, canola, maize, canola meal and cottonseed meal.
Pitch & Tar Products	Pitch, coal tar, tar, carbon black and creosote.
Other Trade	Ammonia, ammonium nitrate, animal foods, coke products, scrap steel, vegetable oils and miscellaneous general cargo.

Commodity Imports	Definition
Fertiliser	Superphosphate, sulphate of ammonia, potash, urea, phosphates and other general manufactured fertilisers.
Machinery, Project Cargo & Vehicles	Industrial machinery, power generation machinery, construction machinery, rail wagons, passenger vehicles and commercial vehicles.
Meals & Grains	Soybean meal.
Pitch & Tar Products	Pitch, coal tar and carbon black.
Other Trade	Ammonia, ammonium nitrate, construction materials, magnetite, timber, tinplate, boats, vegetable oils and miscellaneous general cargo.

i Trade values are based on the Reserve Bank of Australia's exchange rates combined with commodity values and prices obtained from sources such as The World Bank, The Department of Industry, Innovation and Science - Office of the Chief Economists.

ii Vessel visits are based on trading vessels only.
