Notice of Correction: in September 2023, anomalies were identified in the Monthly Trade Reports which resulted in the estimated trade value figures in January and February reports being lower than expected. Similarly, the estimated trade value figures in the July & August reports were significantly higher than expected. The issues that caused the estimated trade value figures to be incorrectly reported in previous versions of these reports have been resolved. Reporting methods have been changed and data validation process improved. As result PON a republished its January to August trade results as at **25th September 2023**.

COMMODITY DEFINITIONS - IMPORTS

Fertiliser: Superphosphate, sulphate of ammonia, potash, urea, phosphates and other general manufactured fertilisers.

Machinery, Project Cargo & Vehicles: Industrial machinery, power generation machinery, construction machinery, rail wagons, passenger vehicles and commercial vehicles.

Meals & Grains: Soybean meal.

Pitch & Tar Products: Pitch, coal tar and carbon black.

Other Trade: Ammonia, ammonium nitrate, construction materials, magnetite, timber, tinsplate, boats, vegetable oils and miscellaneous general cargo.

COMMODITY DEFINITIONS - EXPORTS

Concentrates: Copper ore concentrates, zinc ore concentrates and lead ore concentrates.

Machinery, Project Cargo & Vehicles: Mining machinery, agricultural machinery, power generation machinery, construction machinery, rail wagons, passenger vehicles and commercial vehicles.

Meals & Grains: Barley, sorghum, canola, maize, canola meal and cottonseed meal.

Pitch & Tar Products: Pitch, coal tar, tar, carbon black and creosote.

Other Trade: Ammonia, ammonium nitrate, animal foods, coke products, scrap steel, vegetable oils and miscellaneous general cargo.

i. Trade values are based on the Reserve Bank of Australia's exchange rates combined with commodity values and prices obtained from sources such as The World Bank, The Department of Industry, Innovation and Science - Office of the Chief Economists.

ii. Vessel visits are based on trading vessels only.

iii. Year to date results have been adjusted to reflect the calendar year to date. Previous reports may have been based on financial year to date.

iv. The list of trade destinations indicative, currently is based on full-year 2020 data.
